The California Academy of Family Physicians annually honors a family physician who represents the finest characteristics of the specialty. Nominees for Family Physician of the Year should:

- Embody the finest characteristics of family medicine;
- Be directly and effectively involved in public service and/or activities that enhance the quality of life in communities;
- Have at least five years of practice experience;
- Be in good standing in the medical community; and,
- Be members of CAFP.

CAFP's Staff will submit nominee packets to the Communications Committee for review and selection. The California Family Physician of the Year may be asked to serve as a representative to the media, to write articles for *California Family Physician*, speak to student and resident groups and local chapters, or present a scientific lecture at the Family Medicine Clinical Forum. CAFP's Family Physician of the Year may also be nominated for the AAFP Family Physician of the Year award.
